1. TGR reserves the right to prohibit any Vendor, Exhibit or proposed Exhibit, which, in TGR’s opinion, is not suitable for our event or is in conflict with an existing vendor. In the event that two vendors are merchandising same or similar products, TGR reserves the right to limit this type of exhibit to the first vendor registered.
2. TGR reserves the right to adjust or make changes in booth assignments, up to and including the date of move in, to ensure an even traffic flow.
3. **Each Exhibit will include a 6’ deep x 10’ wide booth, 1- 8’ skirted table with 2 chairs, trashcan and basic electricity. No Exhibit shall be allowed to project into the aisle beyond the assigned space per the fire code. If you need more space, you will need to purchase an additional booth space.**
4. **Exhibits will not be allowed to block the view of other vendors.**
5. Vendors must protect machinery and exhibits in such a way as to ensure that no injury will result to the public, visitors, guests, employees, or any other person or property. Vendors agree to protect and hold harmless TGR and its officers, directors, and employees from any and all persons or actions which may result in injury, loss or damage sustained upon the space occupied by the vendors respectively, or on account of machinery and property under the control of such vendors or on account of negligence of vendors, their representatives, employees or agents.
6. Affixing anything to the walls, doors, floors, or ceiling of function rooms is not permitted unless approval is given in advance. All vendors, their agents or employees shall be responsible for any injury or defacing of the ceiling, walls or floors of the building.
7. TGR will provide private security during the convention. Security personnel will be under the direction of our in-house Director of Security. Security will patrol the premises after hours; however, vendors need to provide their own booth security during Exhibition show hours. TGR will not assume liability for loss or damage by any cause.
8. Neither the TGR nor the management of the hotel will be responsible for any injury which may occur to a vendor its representative or employees, nor for the safety of any exhibit or other property against robbery, fire, accident or any other destructive cause. Insurance, if desired, shall be taken out by the vendor, who hereby agrees to hold TGR harmless and free from all damages or liabilities of any kind.
9. The vendor assumes the entire responsibility and liability for losses, damages, and claims arising out of the vendor’s activities on the premises of the **Inn of the Hills Resort & Conference Center, Kerrville, TX** and will indemnify, defend and hold harmless the Hotel, its agents, servants and employees from any and all such losses, damages and claims.
10. Hotel will not be responsible or liable for any loss, damage or claims arising out of vendor’s activities on the Hotel premises except for any claims, loss, or damage arising directly from its negligence. TGR will be responsible for negotiating the contract with its vendors.
11. Fund raising activities and/or raffles are strictly prohibited unless prior written consent is obtained from TGR.
12. **NO GUN RAFFLES ARE ALLOWED UNLESS APPROVED IN WRITING BY TROPHY GAME RECORDS.**
